



## RACE REGISTRATION & CONTRACT

AN AGREEMENT made the \_\_\_\_\_ day of Two Thousand and Twenty Three BETWEEN **Love Entertainment** of Slaughterhouse Road, Belize City, Belize (hereinafter called “the Organizers”) of the one part and \_\_\_\_\_ of \_\_\_\_\_ (hereinafter called “the Entrant”) of the other part.

### WHEREAS:

- (i) The Organizer is the registered owner of Love Entertainment; and
- (ii) The Organizer is desirous of staging the 4<sup>th</sup> annual , BTB Love Belize Sea Kayak Challenge (hereinafter referred to as “the Event”), on the 30, 31 July; 1, 2, 3, 4 August 2024: Punta Gorda to Placencia , Placencia to Dangriga, Dangriga to Belize City, Belize City to San Pedro, San Pedro to Sarteneja and Sarteneja to Corozal.
- (iii) The said Event is open to all kayakers worldwide.
- (iv) NOW IT IS HEREBY AGREED between the Organizers and the Entrant that this Agreement is subject to the following stipulations:

1. By participating, the Entrant agrees to be bound by the rules (which are provided to Entrants before the Event) and decisions of the Organizers, the timekeepers, and scorekeepers which shall be binding subject only to arbitration or a court order.
2. Participation constitutes your consent and agreement to the recording of your teammates; your performance, appearance, name, voice and likeness of you and your team mates for use in connection with any program (including advertising, marketing, promotion, merchandising and the exploitation of any and all ancillary and subsidiary rights), as the same may be edited, in all media now known or thereafter created, throughout the universe, in perpetuity, for no compensation.

3. The Organizer shall not be liable for: any failure of transportation, bad directions, or inability for any reason to appear; any injuries, losses or damages of any kind caused by traveling to or from the Event venue. The Organizer shall not be liable for any injury or loss of life, loss or damages of kayaks, equipment, and personal effects of any kind during the course of the event. For avoidance of doubt, Love Entertainment and the sponsors assume no responsibility for loss or damage to any equipment or personal effects of groups entering the Event and shall not be responsible for any delays or inconveniences which may be directly or indirectly caused by acts of God or Government.
4. Profanity, indecent gestures, or behavior will result in an immediate elimination from the Event.
5. Consumption of alcoholic beverages prior to and during participation is strictly prohibited and will result in the immediate disqualification of the team.
6. All Entrants by entering the Event are agreeing to unpaid participations in connection with the BTB Love Belize Sea Challenge.
7. If any dispute and questions whatsoever shall arise between the parties hereto or their respective representatives touching this agreement or the construction or application thereof or any clause or thing herein contained in any way relating to this agreement or the affairs dealt with therein or hereunder or the rights, duties or liabilities of the parties to this agreement, efforts shall be made to clarify or rectify same prior to the Event at the Kayak Teams Meeting held before the Event and such meetings should be conducted by the Chairperson of the Committee, if such dispute arises after the Event and the same cannot be resolved or settled between the

- parties then the same shall be referred to three arbitrators, one to be appointed by each party, and one to be appointed jointly.
8. If any dispute shall arise after the Event the aggrieved Team hereby undertakes to deal with it in accordance with the preceding clauses and in particular agrees to refrain from publicizing the same and refrain from lodging or airing complaints and dissatisfactions publicly and specifically through any public forums including but not limited to social networks, newspapers, radio and television stations and undertakes to use its best efforts not to mar the image or reputation of the Event, the Organizer or Sponsors. The violation of this condition will result in disqualification of the Team from such future Events, and or court action.

As a representative of the Entrant:

- a. I hereby grant permission to film, videotape or record in any form, our performance and activities in association with BTB Love Belize Sea Challenge.
- b. I hereby grant RSV Ltd and BTB full and free permission to use, reuse, copyright, and broadcast and/or republish videotape recordings, interviews, and/or photographs of my group and our material in any form, including the use of any printed matter in conjunction therewith. I understand that these may be used for promotional, news, research and/or educational purposes and may be published in any form, including on the internet.
- c. In exchange for release, I receive the opportunity to participate with the complete knowledge that there is no compensation for participation in the Event save for the fact that if my group emerges as a first, second, or third place winner, then I shall be eligible for an award of one of the prizes.
